In consideration of being permitted to participate in any event sponsored, promoted, or directed by Louisiana 4X4 Club Inc., the undersigned for himself or herself, personal representatives, heirs, assigns & relatives, **HEREBY RELEASES** the Louisiana 4X4 Club Inc., and their respective officers, directors, promoters, sponsors, employees, property owners, lessors & their agents, hereafter referred to as **RELEASEES**, of any and all liability to the undersigned, whether caused by the negligent act or omission of Releasees or otherwise while the undersigned is for any purpose participating in such event. It is fully understood by each of the undersigned that there is some inherent risk associated with the event, including damage to vehicles and property, personal, and/or death.

IN ADDITION, the undersigned **AGREES TO INDEMNIFY AND HOLD HARMLESS** the releasees from ant loss, liability damage or cost they incur due to such participation by the undersigned, whether caused by Relesees' negligence or otherwise and **AGREES TO ASSUME FULL RESPONSIBILITY AND RISK** for any bodily injury, death, or property damage from Relesees' acts, negligence or otherwise while the undersigned is participating in this event organized and/or sponsored by the Louisiana 4X4 Club.

In signing this release, each of the undersigned hereby acknowledges and represents the following:

1. That he or she has read the foregoing Release and Waiver of liability and Indemnity Agreement
2. That he or she shall at all times, while riding in a vehicle participating in events, wear their respective seat and shoulder belts.
3. That the owner/driver certifies that he/she has inspected this vehicle and same is in good mechanical condition, and that said vehicle is in compliance with all applicable state laws, including the required liability insurance.
4. That the owner/driver has informed himself/herself about the event and the trail involved in the event, either by prior participation or by investigation into the event or trail.
5. That the owner/driver agrees to assume full responsibility for his/her passengers in his/her vehicle and insures that all passengers have signed a Waiver of Liability Release Form prior to participating in any event sponsored by the Louisiana 4X4 Club.
